Constitution By-Laws / SOP Changes-This will be voted on at business meeting on 9/30/2023

## Proposed Amendment of the Lions District 5SE Constitution

Article VI Officers and District Cabinet, Section 3 Election/Appointment of District Cabinet:

# CURRENT WORDING: The district governor and the first and second vice district governors shall be elected at the annual convention of the district.

PROPOSED WORDING: The district governor and the first and second vice district governors shall be elected at the District 5SE Business meeting held during the State Convention.

Why this change is needed at the District level: Our SOP and the Constitution and Bylaws must provide the basis of the way we are doing business. When the Fall Forum became the Spring Forum our terminology about District Convention and the annual convention of the District has not kept pace with the way we are conducting District 5SE business. This proposed change is an attempt to reflect the current timetable of elections.

Article XI Amendments, Section 1 Amending Procedure: states... This Constitution may be amended only at a district convention by resolution of the Constitution and Bylaws committee, and adopted by the affirmative vote of two-thirds (2/3) of the votes cast.

Section 3 Notice: states...No amendment shall be so reported or voted upon unless the same shall have been published by regular post or electronic means to each club no less than 30 days prior to the convening date of the annual convention with notice that the same will be voted upon at said convention.

Constitution and Bylaws Chair Bob Bell motioned to accept the final SOP as amended. Zone 4 Chair Paul Fixen seconded. Motion carried.

**State Directories-**Zone chairs are reminded to hand out directories for their areas, We mailed directories to Presidents, Secretaries and Treasurers of all areas across the whole state that did not have a Zone chair represented at the August meeting. Secretary Jennie Braaten will send out the electronic copies of the directory to the cabinet, not to be distributed.

**Pin Report**-Pin Chair Donna Weiland reported that new pins are available for \$3.00. Ray Schley is selling old pins at the pin table, too, with those proceeds going to SD Lions Foundation.

**USA Canada Leadership Forum Report**-1<sup>st</sup> Vice DG Dennis Bohmont reported there were 85 different seminars available and around 1700 members in attendance. The next forum is in Louisville, KY the first weekend in Sept 2024.
